RETURNS PREPARED:</p> <p>HOW TO MAKE AN APPOINTMENT:</p>	<p>Income less than \$54,000 Federal, District, Maryland, and Virginia individual income tax returns for 2010-2016.</p> <p>CALL 202-869-2999 to make an appointment or go online at www.communitytaxaiddc.org/appointments.</p>
<p>WE CAN NOT PREPARE:</p>	<p>This is not a complete list and there may be other instances when we cannot prepare a return.</p> <ul style="list-style-type: none"> • You have an A, H, F, J, L, M or Q visa (and do not have a green card or US citizenship) • You were a cab driver. You drove for Uber or Lyft and had gross income over \$5,000 • You had complicated investment income (commonly reported on Schedule D) • Income from Cancelled Debt (Form 1099-C or 1099-A); except in limited circumstances if the cancelled debt is credit card or mortgage debt. • Rental income (including renting out rooms in your own home- no Air B&B) • Self-Employment, business or cash income where your business is an LLC; has net loss, or loss carry over; has inventory, or sale of goods; paid employees, subcontractors; had business use of home; you take vehicle expenses instead of mileage; has depreciation expense; or you do not use cash method of accounting. • Non-cash charitable (Goodwill, etc.) contributions greater than \$500; Vehicle donation • Unreimbursed employee business expenses (Form 2106)
<p>WHAT TO BRING?</p>	<ul style="list-style-type: none"> • Social Security Cards, or ITIN letter for the taxpayer, spouse (if filing jointly), and anyone claimed as a dependent • Valid Photo ID for taxpayer and spouse (if filing jointly) • All W-2's, 1099's, bank interest statements and other income information • Record of expenses for tax credits and deductions (child care, education, student loans, medical expenses) • Account and Routing Number for direct deposit of your refund • Income statements for all your dependents (W2s, 1099-SSAs, etc.) • 1095-A (if you purchased insurance through the Marketplace/Exchange) • A copy of your 2015 tax return if available • If you are filing a joint return, and your spouse cannot come in person, you must bring a power of attorney (IRS form 2848)
